2026/2027 Insurance Renewal

The 2026/2027 insurance requirements for the Parish will be presented at the Congregational meeting to be held on Sunday 5th July. Below are the main points:

Current cover expires at 4.00pm on 1st August

- Property
- Contents
- Business Interruption
- Liability

Property

Valuation by Independent Registered Valuer – preferred, but costly

Modal Valuation tool – a good alternative

Manse

Calculated Replacement Value (RV) \$1,336,218

Church Property Trustees require cover at 100% RV \$1,336,218 (includes cover for Natural Disaster)

Waikanae church complex

Calculated Replacement Value \$4,525,140

Insurers require minimum sum insured of 75% of Replacement Value – Functional Replacement Value \$3,393,855

Insured for Material Damage (fire, water or wind damage) but **NOT** for Natural Disaster

Complex assessed at 100% of New Building Standard

Otaki church complex

Calculated Replacement Value \$3,850,350. Full Replacement cover will need to be maintained while the property is on the market for sale.

Insured for Material Damage (fire, water or wind damage) but **NOT** for Natural Disaster

Complex assessed at 100% of New Building Standard

Contents

Waikanae Manse \$25,000

Waikanae church complex \$425,000

Otaki church complex \$100,000

The organ, projectors and laptops are included in overall contents

Business Interruption

Waikanae Manse \$38,500

New Business Interruption cover in respect of the Waikanae facility hire fees \$18,000

Liability

These policies are taken out by the PCANZ Assembly Executive Secretary on behalf of all parishes nation wide

Recommendation:
