2025/2026 Insurance Renewal

The 2025/2026 insurance requirements for the Parish will be presented at the Congregational meeting to be held on Sunday 21st July. Below are the main points:

Current cover expires at 4.00pm on 1st August

- Property
- Contents
- Business Interruption
- Liability

Property

Valuation by Independent Registered Valuer – preferred, but costly

Modal Valuation tool – a good alternative

Manse

Calculated Reinstatement Value (RV) \$907,980

Church Property Trustees require cover at 100% RV \$907,980 (includes cover for Natural Disaster)

Waikanae church complex

Calculated Reinstatement Value \$4,506,060

Insurers require minimum sum insured of 75% of Reinstatement Value – Agreed Value \$3,379,545 Insured for Material Damage (fire, water or wind damage) but **NOT** for Natural Disaster

Complex assessed at 100% of New Building Standard

Otaki church complex

Calculated Reinstatement Value \$3,446,020

Insurers require minimum sum insured of 75% of Reinstatement Value – Agreed Value \$2,577,015

Insured for Material Damage (fire, water or wind damage) but **NOT** for Natural Disaster

Complex assessed at 100% of New Building Standard

Contents

Waikanae Manse \$20,000

Waikanae church complex \$400,000 – increase to \$425,000

Otaki church complex \$200,000 – increase to \$215,000

The organ, projectors and laptops are included in overall contents

Business Interruption

Waikanae Manse \$38,500

New Business Interruption cover in respect of Otaki and Waikanae facility hire fees \$15,000

Liability

These policies are taken out by the PCANZ Assembly Executive Secretary on behalf of all parishes nation wide

Recommendation:

That the Congregation endorses the Parish Council's decision to accept the proposed insurance renewals for the 2025/2026 year.
